

# Privacy Policy

Brew Love Software, LLC (“**Brew Love**” “**us,**” “**our,**” or “**we**”) is committed to protecting your privacy. This privacy policy (the “**Policy**”) applies to the Brew Love SaaS product and website, accessible online at Brewlovesoftware.com, or any other website or service where this Policy is posted (the “**Service**”). This Policy contains details regarding the information we collect when you visit our Service, how we (or others on whose behalf the information is collected) may use, process, and share that information, your choices with regard to your information, and other related matters. This Policy is incorporated into our Terms of Use. Through your use of any Service, you consent to the practices described in this Policy.

Except as otherwise expressly set forth below, this Policy is applicable to only information we collect online using our Service. This policy does not apply to any information that you provide offline, whether in person, over the phone, or otherwise. Similarly, this Policy does not apply to information collected by third parties, regardless whether you arrive at such third parties’ sites or services using our Service.

## Personal information we collect and how we use it

Brew Love may collect personal information from you when you use our Service. Personal information includes any information that can be used to identify you as an individual, either alone or in combination with other information.

For example, if you contact us through our Service, Brew Love collects personal information, such as your e-mail address. If you contact us directly, for example, regarding a product you would like to learn more about, we will send you information relevant to your request or contact you about that product, and we may send you additional communications about that products or other products provided by Brew Love, our partners and affiliates. If you contact us regarding other matters, we will use your contact and other information you choose to provide only in the context of your inquiry or request.

When you sign up for a free trial of the service, we will collect personal information such as your name, the name of your brewery, email and phone, and you will be asked to create a user name and password. If you purchase our product, we will collect additional information from you, including your credit card number, expiration date and CVC code. We use this information only to manage your account, provide the service, and, when applicable, process your payment. We may use and transmit your credit card information to a third party payment processor that handles transactions on our behalf.

We may collect anonymous analytics data from you when you browse our Service. Such data is not unique to you and cannot typically be used to identify you. This information typically includes common technical and demographic data such as: your IP address, browser type, domain names, access times and referring Web Service addresses, your ZIP code, age, gender, preferences, interests and favorites. We may also log click-stream information that is collected by our computers when you request pages from the Service. Click-stream data typically includes information such as the page served, the time, the source and type of browser making the request, the most recent page view, and other non-personal information. We collect these types of data for purposes of system administration, to improve our Service, and for other internal uses related to the

Service. This data also helps us analyze how visitors arrive at our Service, what type of content is most popular, what type of visitors in the aggregate are interested in particular features or content, and the like.

## **Use of cookies and similar tracking technologies**

Our Service may use cookies, web beacons and similar tracking technologies. These technologies are widely used for security, to learn about and improve upon how users navigate a Service or to enable certain features. Cookies are small data files that are transferred to your hard drive when your browser settings permit the acceptance of cookies. Similar technologies, such as web beacons or pixel tags function through the use of small files, such as a GIF or PNG, which are opened on a page or in an email. The request for these files from a server reveals certain information, such as your browser type, IP address, and other information. We make no representations or warranty regarding any third-party’s use, collection or disclosure of your personal information.
